A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO WAIVING PORTIONS OF COUNCIL
POLICY 100-03, AND ALLOCATING DISCRETIONARY
TOT FUNDING TO KIWANIS CLUB OF TORREY PINES FOR
THE LA JOLLA FESTIVAL OF THE ARTS

WHEREAS, funds were allocated in the Fiscal Year 2011 Annual Budget for Special Promotional Programs intended to advance the City's economy by promoting the City of San Diego as a visitor destination in the national and international marketplace; and

WHEREAS, the Kiwanis Club of Torrey Pines, La Jolla, California (Kiwanis Club) is committed to raising funds for organizations which aid physically or mentally challenged individuals in San Diego County through various recreational and support programs; and

WHEREAS, the Kiwanis Club is a non-profit volunteer organization located in the La Jolla area; and

WHEREAS, the Kiwanis Club has requested funding for the La Jolla Festival of the Arts which is a top-rated California art show that features the work of nearly 200 award-winning artists and master craftspeople from all over the nation; and

WHEREAS, it is the determination of the Council that the La Jolla Festival of the Arts program fits within the parameters of the Special Promotional Programs set forth in the Fiscal Year 2011 Annual Budget; and

WHEREAS, the City desires to enter into an agreement with the Kiwanis Club to promote the Arts and Cultural elements of our community, and the Kiwanis club has agreed to promote such elements; and


WHEREAS, the Kiwanis Club has proposed to expend \$178,500 for these projects and has requested the City of San Diego provide \$7,500 in funding for the projects from the Special Promotional Programs, Mayor and City Council Discretionary Funding line item set forth in the Special Promotional Programs portion of the Annual Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that all general requirements of Council Policy 100-03 regarding application and funding recommendations are hereby waived.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, an Agreement in an amount not to exceed \$7,500 for the Kiwanis Club for the La Jolla Festival of Arts program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$7,500 from the Special Promotional Programs, Mayor and City Council Discretionary Funding, for the above described project, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
