DATE OF FINAL PASSAGE JUN 13 2011

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER OF FUNDS FOR STORM DRAIN PROJECTS.

WHEREAS, the Transportation and Storm Water Department has identified several storm drains and facilities that were severely damaged by the series of winter storms in 2010 that are in urgent need of repair/replacement; and

WHEREAS, the specific storm drains in need of repair are the Bounty Street Storm Drain, Via Esprillo Storm Drain, and Carmel Mountain Road Storm Drain; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to transfer an amount not to exceed \$608,000 from the General Fund – Storm Water Department, fund 100000, General Fund, Business Area 2114, Cost Center 2114111212, to Fund 400265, General Fund contributions to the CIP; and

2. That the Mayor, or his designee, is authorized to transfer \$56,529 from CIP S-00924, Prospect Street/Silverado Street Roundabout project, Fund 400156, Prop. A (1/2% Sales Tax), to CIP A-CA.00001, Annual Allocation Drainage Projects; and

3. That the Mayor, or his designee, is authorized to transfer \$520,481 from CIP S-00610, Fashion Valley Road project, Fund 400156, Prop A (1/2% Sales Tax), to CIP A-CA.00001, Annual Allocation Drainage Projects; and

4. That the increase to the Fiscal Year 2011 Capital Improvements Program budget by an amount not to exceed \$608,000 in Fund 400265, General Funds contributions to the CIP,

CIP A-CA.00001, Annual Allocation-Drainage Projects is authorized, contingent upon the Chief Financial Officer first certifying that the funds are, or will be, on deposit with the City Treasurer.

5. That the City Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
