A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A TWO-YEAR AGREEMENT
WITH RURAL/METRO OF SAN DIEGO, INC. FOR
EMERGENCY MEDICAL SERVICES.

WHEREAS, on July 31, 2009, the City Council passed Resolution No. 305179,
authorizing the Mayor or his designee to negotiate and execute a contract with San Diego
Medical Services Enterprise [SDMSE] for Emergency Medical Services [EMS]; and

WHEREAS, pursuant to that Resolution, the City negotiated and executed an EMS
agreement with SDMSE, which had a start date of July 1, 2010 [2010 EMS Agreement]; and

WHEREAS, on or before June 30, 2011, Rural/Metro of San Diego, Inc. or its affiliate
[Rural/Metro] will purchase the City's ownership interest in SDMSE, and SDMSE will no longer
provide EMS to the City directly; and

WHEREAS, the City will commence a competitive process for a new EMS provider,
which is expected to be completed within two years; and

WHEREAS, to prevent an interruption in critical emergency services during the
competitive process, Rural/Metro has agreed to provide EMS to the City during this two-year
period on a sole source basis commencing on or before July 1, 2011; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor or his designee is authorized to execute, for and on behalf of the City, a
two-year agreement with Rural/Metro, under the terms and conditions set forth in the
agreement entitled "2011 Emergency Medical Services Agreement between
Rural/Metro of San Diego, Inc. and the City of San Diego," in accordance with


Option 3 for fees and Average Patient Rates, on file as Document No.

RR 306852. This two-year agreement will replace and supersede the 2010 EMS Agreement.

- 2. To the extent not finalized, the City Attorney shall prepare the relevant contract documents to be executed on or before June 15, 2011, unless the parties mutually agree in writing to later date prior to July 1, 2011.
