BE IT FURTHER RESOLVED, that the Chief Financial Officer, as delegated to Financial Management is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$2,853,135.00 from Water Fund 700011, CIP A-KB.00003, Annual Allocations-Main Replacements (B-10175) for the design, construction and related costs of the Project, contingent upon the City Comptroller first furnishing one or more certificates

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the use of City Work Force in Water Fund 700011, CIP A-KB.00003, Annual Allocation – Water Main Replacements (B-10175) in the amount not to exceed \$170,000.00 is authorized for the design, construction and related costs of the Project.

BE IT FURTHER RESOLVED, that the City Comptroller, upon advice from the administering department, is authorized to return excess budgeted funds, if any, to the appropriate reserves.
