WHEREAS, the Mission Bay Park Committee is established in San Diego Municipal Code section 26.30(g) to serve in an advisory capacity to the Park and Recreation Board, Mayor, City Council, and City Manager on policy issues relating to the acquisition, development, maintenance, and operation of Mission Bay Park; and

WHEREAS, effective July 1, 2009, the Mission Bay Park Committee also fulfills the role of the Mission Bay Park Improvement Fund Oversight Committee as described in Charter section 55.2; and

WHEREAS, in order to satisfy the requirements of Charter section 55.2, each member of the Mission Bay Park Committee must possess expertise, or demonstrated experience or knowledge in one or more of the following areas: auditing, finance or municipal finance, general business, planning, biology or environmental science, resource management or protection, wildlife management or protection, construction management, recreation management or planning; and

WHEREAS, the Mission Bay Park Committee consists of eleven members who serve without compensation; and

WHEREAS, the members are appointed by the Mayor and confirmed by the City Council subject to the following conditions: the Mayor appoints three members from nominations submitted by the Councilmember for Council District Two and three members from nominations

submitted by the Councilmember for Council District Six; the Mayor appoints three at-large members; the Mayor appoints one Mission Bay lessee who represents a hotel in the Park; and the Mayor appoints one Mission Bay lessee who represents a lessee in the Park other than a hotel; and

WHEREAS, members serve two-year staggered terms for a maximum of eight consecutive years and until a successor is appointed; and

WHEREAS, members are appointed in such a manner that the terms of not more than six members expire in any year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointments by the Mayor of the City of San Diego to serve as members of the Mission Bay Park Committee be and the same are hereby confirmed:

BE IT FURTHER RESOLVED, that pursuant to Council Policy 000-13, for purposes of deliberation and consideration of appointment, it is determined that Patrick Owen is a resident of San Diego County, but not the City of San Diego, and has unique qualifications to serve as a

member of the Mission Bay Park Committee. Therefore, a conscious exception to Council Policy 000-13 is hereby declared.
