DATE OF FINAL PASSAGE JUL 27 2011

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE INSTALLATION OF ANGLE PARKING ON CENTRE STREET, LINCOLN AVENUE, AND POLK AVENUE IN THE VICINITY OF PARK BOULEVARD.

WHEREAS, the Transportation Engineering Operations Division of the Transportation and Stormwater Department has reviewed a petition requesting angle parking on blocks of Centre Street, Lincoln Avenue, and Polk Avenue near Park Boulevard; and

WHEREAS, the installation of angle parking in these locations was contemplated as a part of SANDAG's Mid-City Rapid Bus Project; and

WHEREAS, the expenditures necessary to convert these locations to angle parking in the amount of approximately \$16,000 will be paid by SANDAG as part of the Mid-City Rapid Bus Project; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the installation of angle parking on the west side of Centre Street between Park Boulevard and Blaine Avenue and on the east side of Centre Street between Lincoln Avenue and Park Boulevard is authorized.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the installation of angle parking on the north side of Lincoln Avenue between Park Boulevard and Normal Street is authorized.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the installation of angle parking on the north side of Polk Avenue between Park Boulevard and Normal Street is authorized.


BE IT FURTHER RESOLVED, that the installation of necessary signs and marking for such angle parking is authorized, and the regulations shall become effective on installation of the signs.
