A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO RATIFYING THE ELECTION RESULTS OF THE
JUNE 23, 2011 PROJECT AREA COMMITTEE ELECTION FOR
THE CROSSROADS REDEVELOPMENT PROJECT.

WHEREAS, on May 6, 2003, the City Council of the City of San Diego [Council] adopted Ordinance No. O-19174 (NEW SERIES), thereby approving and authorizing the Redevelopment Plan for the Crossroads Redevelopment Project Area; and

WHEREAS, California Health and Safety Code Section 33385 requires that the Council adopt formation procedures for redevelopment project area committees; and

WHEREAS, on April 2, 2022 by Resolution No. R-296253, the Council adopted formation procedures [Procedures] for the Crossroads Redevelopment Project Area Committee [Crossroads PAC]; and

WHEREAS, on December 8, 2003, by Resolution No. R- 298702, the Council amended the Procedures; and

WHEREAS, California Community Redevelopment Law requires that project area committees remain in existence for three years from the date of adoption of the redevelopment plan and are thereafter subject to one-year extensions by the legislative body; and

WHEREAS, on or about January 18, 2011, the Council, by Resolution No. R-306529, approved a one-year extension of the Crossroads PAC and directed the staff or the Redevelopment Agency of the City of San Diego to notice and conduct the annual Crossroads PAC election for 2011; and

WHEREAS, after notice and in accordance with the Procedures, the Crossroads PAC Bylaws, and applicable law, the annual Crossroads PAC election [Election] was conducted on June 23, 2011; and

WHEREAS, a representative from the City Clerk's Office attended the Election to ensure its validity and provide official verification of the tallying of ballots and Election results;


NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of San Diego as follows:

1. That the Crossroads PAC, including those persons who received the highest number of votes in their respective categories at the Election and listed on the City Clerk's Office's verification of the Election results (attached hereto as Exhibit "A" and incorporated herein by this reference), is hereby approved as constituting the representative Crossroads PAC.

2. That the Election results of June 23, 2011 are valid and binding in accordance with the Procedures.
