A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER OF FUNDS FOR THE CONSTRUCTION OF THE WEGEFORTH ELEMENTARY SCHOOL JOINT USE PARK IMPROVEMENTS PROJECT.

WHEREAS, the Wegeforth Elementary School Joint Use Park Improvements (Project) provides for the design and construction of approximately 4.0 acres at Wegeforth Elementary School for joint use facilities to meet population base requirements and to supplement existing park acreage in the Serra Mesa community; and

WHEREAS, the proposed improvements include a turf-ed multi-purpose sports field, courts, walkways, landscaping, parking, security lights, drainage, a comfort station and accessibility upgrades; and

WHEREAS, this Project will promote the community's recreational, social, and cultural benefits; and

WHEREAS, Project has been conceptually designed in conjunction with the community and within the guidelines of the Serra Mesa Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Chief Financial Officer is authorized to transfer appropriations in the amount of \$1,100,000 from CIP S-00751, Hickman Fields, Fund 400132, Serra Mesa Urban Community Development Impact Fee Funds (DIF) to CIP S-00764, Wegeforth Elementary School Joint Use, for the purpose of funding construction of the Project.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,100,000 from CIP S-00764, Wegeforth Elementary School Joint Use, Fund 400132, Serra Mesa Urban Community Development Impact Fee Funds (DIF), for the purpose of construction of the Project.

3. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
