A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE ASSESSMENT ENGINEER'S  
REPORTS SUBMITTED IN CONNECTION WITH THE CITY-  
MANAGED MAINTENANCE ASSESSMENT DISTRICTS FOR  
FISCAL YEAR 2012.

WHEREAS, the City formed each of the Maintenance Assessment Districts specified below pursuant to Article XIID of the California Constitution, the Proposition 218 Omnibus Implementation Act (California Government Code section 53750 *et seq.*), the Landscape and Lighting Act of 1972 (California Streets and Highways Code section 22500 *et seq.*), and San Diego Municipal Code section 65.0211; and

WHEREAS, each year City Council also approves certain updates to the Engineer's Reports, such as: modifying the assessment rates within the approved assessment formula for cost indexing, maximum assessment rates, and reserve limits; identifying property and land use changes that may impact the calculation of the assessment rate; reviewing the scope of services for improvements to comply with the approved assessment methodology; incorporating general benefit rates proposed for the new Fiscal Year; and integrating the proposed budget for the new Fiscal Year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Reports submitted in connection with the City-managed Maintenance Assessment Districts and filed in the office of the City Clerk as follows are hereby approved as filed:


