A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING A FIVE-YEAR WORK PLAN TOWARD THE GOAL OF ENDING HOMELESSNESS IN DOWNTOWN SAN DIEGO.

WHEREAS, Centre City Development Corporation, Inc. (CCDC) administers certain redevelopment activities, on behalf of the Redevelopment Agency of the City of San Diego (Agency), and certain design review and permitting activities, on behalf of the City of San Diego, in the vast majority of downtown San Diego; and

WHEREAS, CCDC has caused the preparation of that certain "Five-Year Work Plan Toward Goal of Ending Homelessness in Downtown San Diego" covering the period from July 1, 2011 through June 30, 2016 (Work Plan), a copy of which is included as Attachment B to Staff Report No. CCDC-11-21 accompanying this matter; and

WHEREAS, the Work Plan identifies certain strategies, action steps, and tasks that can be explored and potentially implemented by CCDC and other entities, including the San Diego Housing Commission, to achieve reductions in chronic street homelessness and to help make significant progress toward the goal of ending homelessness in downtown San Diego; and

WHEREAS, the Council's approval of the Work Plan commits no public funds at this time, and it is anticipated that any future actions involving an encumbrance of public funds for the implementation of the Work Plan will require future approvals by the Council or the Agency's Board of Directors, or both; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council finds and determines that the foregoing recitals are true and correct.

- 2. The Council has received and heard all oral and written objections pertaining to this matter, and all such oral and written objections are hereby overruled.
- 3. The Council hereby approves the Work Plan, a copy of which shall be placed on file in the office of the City Clerk as Document No. RR-30599.
- 4. CCDC staff, as part of CCDC's annual budget process and during the effectiveness of the Work Plan, shall provide annual updates to the Council or the Agency's Board of Directors, or both, with respect to accomplishments achieved during the prior year and goals to be pursued during the upcoming year pursuant to the Work Plan.
