RESOLUTION NUMBER R- 307014 DATE OF FINAL PASSAGE SEP 28 2011

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING PAYMENT OF PREVAILING WAGES; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACTS; AND TAKING RELATED ACTIONS REGARDING SLURRY SEAL OF STREETS PROJECTS FOR FISCAL YEAR 2011: GROUPS VI, VII, AND VIII.

WHEREAS, as part of the City's street maintenance program and subject to Council approval, contracts are awarded to apply slurry seal to selected groups of streets; and

WHEREAS, funding is available for Groups VI, VII, and VIII from Proposition 42 Fund 200306, Assembly Bill 2928; and

WHEREAS, the Council has the discretion to require that prevailing wages be paid on its public works municipal affair projects when the Council determines that doing so will provide an economic benefit to the City; and

WHEREAS, the Council by Resolution No. R-298185 directed the advertising and including of a prevailing wage specification on all City public works municipal affair public utilities projects when the engineer's estimate for the construction of the project exceeds ten million dollars; and

WHEREAS, Resolution No. R-298185 further provides that the City Council will determine on a project-by-project basis, based on the evidence in the record, whether a public utilities project, subject to prevailing wage requirements, will be awarded; and

WHEREAS, the Slurry Seal of Streets Projects for Groups VI, VII, and VIII are public utilities projects falling within the parameters of Resolution No. R-298185; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council finds and determines that requiring payment of prevailing wages on the Slurry Seal of Streets Projects Groups VI, VII, and VIII will provide an economic benefit.
- 2. That the Chief Financial Officer is authorized to accept, for and on behalf of the City, up to \$10,562,980 in Fiscal Year 2011 Proposition 42 funding, Fund No. 200306, Assembly Bill 2928.
- 3. That the plans and specifications, as advertised by the Contract Administrator, Purchasing & Contracting Department for bids, are approved for the following projects:
- (a) Slurry Seal Fiscal Year 2011, Group VI, under the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR-307014; and
- (b) Slurry Seal Fiscal Year 2011, Group VII, under the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR- $\frac{307014}{4}$; and
- (c) Slurry Seal Fiscal Year 2011, Group VIII, under the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR-307014.
- 4. That after advertising for bids in accordance with law, the Mayor or his designee is authorized to award and execute construction contracts for the above projects, provided that the Chief Financial Officer certifies that the funds are, or will be, on deposit with the City Treasurer, to be awarded as follows:
- (a) to the Lowest Responsible and Reliable Bidder in an amount not to exceed \$3,196,986 for Slurry Seal Fiscal Year 2011, Group VI; and
- (b) to the Lowest Responsible and Reliable Bidder in an amount not to exceed \$3,239,971 for Slurry Seal Fiscal Year 2011, Group VII; and
- (c) to the Lowest Responsible and Reliable Bidder in an amount not to exceed \$3,207,503 for Slurry Seal Fiscal Year 2011, Group VIII.

- 5. That the Chief Financial Officer is authorized to expend an amount not to exceed \$10,562,980 from Fund No. 200306, Assembly Bill 2928, solely and exclusively to provide funds for the above projects and related costs, contingent on the Chief Financial Officer certifying that the funds are available, to be expended as follows:
- (a) an amount not to exceed \$3,501,461 for Slurry Seal, Fiscal Year 2011, Group VI; and .
- (b) an amount not to exceed \$3,548,539 for Slurry Seal, Fiscal Year 2011, Group VII; and
 - (c) an amount not to exceed \$3,512,980 for Slurry Seal, Fiscal Year 2011, Group VIII.
