WHEREAS, the City of San Diego awarded a Design-Build Contract to 3-D Enterprises,
Inc. to handle Americans with Disabilities Act (ADA) improvements at several locations; and
WHEREAS, the Colina Del Sol pool was one of the locations included in their contract;
and

WHEREAS, the Colina Del Sol ADA Improvements Project (WBS No. S-01047) was cancelled at the request of the Park and Recreation Department because at that time the pool was being considered for closure; and

WHEREAS, once this portion of work was cancelled the funds were reprogrammed to the Clairemont, Skyline, and University Branch Libraries, and the Memorial Pool, which were also ADA Community Development Block Grant (CDBG) projects which had a funding gap; NOW THEREFORE,

BE IT RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$6,000 from CIP ABE-00001, Americans with Disabilities Improvements, to CIP S-01047, Colina Del Sol Pool ADA, within Fund 400002, Capital Outlay; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend \$6,000 from CIP S-01047, Colina Del Sol Pool ADA, Fund 400002, Capital Outlay, for the purpose of paying for the close-out invoice to 3-D Enterprise, Inc. for design services performed before the project was cancelled; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to return remaining appropriations at project close out from CIP S-01047, Colina Del Sol Pool ADA to CIP ABE-00001, Americans with Disabilities Improvements, within Fund 400002, Capital Outlay.
