Annual Allocation – MWWD Trunk Sewers (B-00481) for the Project's construction contract,

contingent upon approval of the Fiscal Year 2012 Appropriation Ordinance, and the City

Comptroller first furnishing one or more certificates certifying that the funds necessary for

expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$77,000.00 from Sewer Fund 700008, CIP A-JB.00001, Annual Allocation – MWWD Trunk Sewers (B-00481) for property acquisition related expenses is authorized, contingent upon approval of the Fiscal Year 2012 Appropriation Ordinance.
