A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CITY STAFF TO MAKE FINAL REVISIONS TO THE FISCAL YEAR 2011 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT AND SUBMIT IT TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

WHEREAS, the City of San Diego is required to submit a Consolidated Annual Performance and Evaluation Report (CAPER) to the Department of Housing and Urban Development (HUD) at the end of each fiscal year; and

WHEREAS, the CAPER details the City's accomplishments toward meeting the goals, priorities, and objectives outlined in its FY 2010-2014 Consolidated Plan; and

WHEREAS, the CAPER compares the actual performance measures with the performance measures listed in the FY 2011 Action Plan, which is developed before the fiscal year; and

WHEREAS, the CAPER reports on activities funded by Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), Emergency Shelter Grant (ESG), and Housing Opportunities for Persons with Aids (HOPWA); and

WHEREAS, federal regulations require that the City provide a period of not less than 15 days to receive public comments on the CAPER and hold a public hearing before the CAPER is submitted to HUD; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City has conducted a public hearing on the City's FY 2011 CAPER for the CDBG, HOME, ESG, and HOPWA

programs and has heard and considered all public comments received regarding the CAPER in writing or orally at such public hearing.

BE IT FURTHER RESOLVED, that the FY 2011 CAPER is approved and that the Mayor or his designee is authorized to make all necessary modifications to finalize the CAPER so that it is consistent with the requirements from HUD's Office of Community Planning and Development.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to submit the City's FY 2011 CAPER to HUD by September 28, 2011, as required by HUD.
