DATE OF FINAL PASSAGE OCT 3 2011

APPROVING THE CITY COUNCIL'S RESPONSE TO THE
2010-2011 SAN DIEGO GRAND JURY REPORT TITLED "NO
'COST' FOR ALARM?"

WHEREAS, on June 1, 2011, the 2010-2011 San Diego County Grand Jury (Grand Jury) filed a report titled "No 'Cost' for Alarm?" (Report) that requested responses from the City of San Diego on seven recommendations in the Report; and

WHEREAS, of the seven recommendations, four were directed to the Police Department and three were directed to the Mayor and the City Council; and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, due to the demands of the City's legislative calendar and the future release of an audit of the permits and licensing unit of the Police Department, the Presiding Judge of the Superior Court has extended the time for the City Council to respond until November 1, 2011; and

WHEREAS, the Grand Jury examined several issues relating to complaints of financial accounting improprieties in the Permits and Licensing Unit of the Police Department, particularly relating to the alarm permits program and requested that the City Council respond to the findings and recommendations 11-48 through 11-50 in the Report; and

WHEREAS, the Office of the Independent Budget Analyst has prepared a proposed response to the Report as set forth in IBA Report No. 11-54 dated September 12, 2011, for the City Council's consideration; and


WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves and adopts as its own the response to the 2010-2011 San Diego County Grand Jury Report titled "NO 'COST' FOR ALARM?" as set forth in IBA Report No. 11-54 dated September 12, 2011.

BE IT FURTHER RESOLVED, that the Council President is authorized and directed, on behalf of the San Diego City Council, to execute and deliver the above-described response to the Presiding Judge of the San Diego County Superior Court no later than November 1, 2011.
