WHEREAS, the CAFR is the responsibility of the City management and the role of the Council, as part of its legislative oversight responsibilities, is to determine, to each Council members satisfaction, based on the process followed, including the certifications of certain City officials regarding the CAFR, and applying the knowledge that each Council member has of the City's affairs, that there is no reason the CAFR should not be made available to investors and the securities markets as an official document of the City; and

WHEREAS, while the Council is not required to review the City's CAFRs this Council deems it prudent and a best practice for the Council to do so to ensure that appropriate and reasonable processes have been followed in the preparation of CAFRs since they contain the City's financial statements and other information that will be included in official statements and other disclosure documents used in connection with sale of securities of the City and its related entities, which will require approval by the Council; and

WHEREAS, in receiving the City's Fiscal Year 2010 CAFR, the Council deems it prudent to review the Yellow Book Report accompanying the audit; and

WHEREAS, in accordance with sections 22.4108(a)(1) and 22.4111 of the San Diego Municipal Code and the Disclosure Controls and Procedures adopted by the Disclosure Practices Working Group [DPWG], DPWG reviewed the draft of the Fiscal Year 2010 CAFR presented to the DPWG on July 27, 2011, including approved revisions at subsequent meetings and incorporated into the 2010 CAFR, and in the best judgment of the DPWG, such draft was in substantially final form, subject to the receipt of the final opinion letter of Macias and the certification of the Chief Financial Officer, and the certifications of the Chief Financial Officer and the DPWG are on file with City Clerk as Document No. RR- 307038 and Document No. RR- 307038 and

WHEREAS, on September 12 and September 26, 2011, the Audit Committee reviewed the 2010 CAFR in accordance with its the procedures and recommended that the Council receive and file the 2010 CAFR; NOW, THEREFORE,
