A RESOLUTION AUTHORIZING COUNCIL TO AWARD CONTRACT TO ORION CONSTRUCTION FOR THE DESIGN AND CONSTRUCTION OF WATER GROUP JOB 922 DESIGN BUILD.

WHEREAS, Water Group Job 922 Design Build [the Project] is part of the City of San Diego's [City] Water Main Replacement Program as mandated by the California Department of Public Health; and

WHEREAS, the City issued a Request for Proposal to retain the services of a design-build company to provide design and construction services for the Project; and

WHEREAS, Orion Construction was selected as the most qualified firm following a competitive selection process to provide design-build design services, and will prepare the final design plans and specifications for the replacement of 1.39 miles of water mains designed to improve service to customers pursuant to the City's standards; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized and empowered to award a contract to Orion Construction for the design and construction of the Project in an amount not to exceed \$2,647,000, under the terms and conditions set forth in the contract, on file in the Office of the City Clerk, as Document No. RR-307039.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, as delegated to Financial Management is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$2,647,000 from Water Fund 700010, CIP A-KB.00003, Annual Allocation-Water Main Replacements (B-10172) for the design and construction of the

Project, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the use of City Work Force in Water Fund 700010, CIP A-KB.00003, Annual Allocation – Water Main Replacements (B-10172) in the amount not to exceed \$230,000 is authorized for the design, construction and related costs of the Project.


