DATE OF FINAL PASSAGE OCT 25 2011

A RESOLUTION OF THE CITY COUNCIL ADOPTING COUNCIL POLICY 400-15 AND RESCINDING COUNCIL POLICIES 400-09, 400-11 AND 400-12, ALL REGARDING WATER SUPPLY AND CONSERVATION.

WHEREAS, San Diego's economy and quality of life depend on a reliable and relatively inexpensive supply of water; and

WHEREAS, the City's existing guiding principles for water are found in a patchwork of incompatible and out-of-date Council Policies, including Council Policies 400-09, 400-11 and 400-12; and

WHEREAS, the City needs a new comprehensive policy for a sustainable water supply that embraces new technologies and innovation, encourages collaboration on all levels, and contains performance measures and regular review; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council Policy 400-15 entitled "Comprehensive Policy for a Sustainable Water Supply in San Diego" is hereby adopted as set forth in the Council Policy on file in the Office of the City Clerk as Document No.



BE IT FURTHER RESOLVED, that the City Clerk is instructed to add Council Policy 400-15 to the Council Policy Manual, and to remove Council Policies 400-09, 400-11 and 400-12.

BE IT FURTHER RESOLVED, that the question of whether and how to form a task force to develop an implementation plan for Council Policy 400-15 is referred to the Natural Resources and Culture Committee for further discussion.


