A RESOLUTION OF THE CITY COUNCIL AUTHORIZING A THIRD AMENDMENT TO THE AGREEMENT WITH OCEAN BLUE ENVIRONMENTAL SERVICES, INC., FOR AS-NEEDED HAZARDOUS WASTE MANAGEMENT SERVICES, WITH OPTION TO RENEW FOR ONE MORE YEAR; AND AUTHORIZING EXPENDITURES THEREFOR.

WHEREAS, the City entered into an agreement with Ocean Blue Environmental Services, Inc., for as-needed hazardous waste management services for City departments and operations, for a term of one year with options to renew the agreement for four additional one-year periods, in accordance with Bid No. 9075-08-A; and

WHEREAS, the City exercised the first two options to renew the agreement, and the City now wishes to exercise the third option to renew the agreement for another one-year term; and

WHEREAS, the Natural Resources & Culture Committee unanimously recommended approval of this requested action on April 20, 2011; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a third amendment to the agreement with Ocean Blue Environmental Services, Inc., for as-needed hazardous waste management services for a term of one year from November 1, 2011 through October 31, 2012 in an amount not to exceed \$1,000,000, with an option to renew the agreement for an additional one-year period with price increases not to exceed the annual San Diego Consumer Price Index (CPI) of the prices in effect at the end of the prior contract year, all in accordance with Bid No. 9075-08-A, under the terms and conditions set forth in the Third Amendment, on file with the City Clerk as Document No. RR- 307059 .

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000,000 annually, plus any annual CPI price escalation as authorized per Bid No. 9075-08-A, as-needed from the various City Departments that request hazardous waste management services, contingent on the City Council approving funding for services under Bid No. 9075-08-A in the applicable fiscal years.

3. That the City Comptroller is authorized to transfer expended funds from each participating City Department requiring hazardous waste management services upon advice of the administering department.
