A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE TRANSFER AND
EXPENDITURE OF FUNDS FROM DEVELOPMENT
IMPACT FEES FOR ANGIER ELEMENTARY SCHOOL
JOINT USE PARK IMPROVEMENTS.

WHEREAS, proposed improvements to the joint use field at Angier Elementary School
have been approved under the Serra Mesa Community Plan guidelines; and

WHEREAS, with Council approval, phase one of the proposed improvements can be
completed; and

WHEREAS, developer impact fees are available to fund the proposed improvements;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That in accordance with the annual appropriation ordinance, the Chief Financial
Officer, or designee, is authorized to amend the Fiscal Year 2012 Capital Improvement Program
budget by increasing CIP S-00762, Angier Elementary School Joint Use Park Improvements,
Fund No. 400132, Serra Mesa Urban Community Development Impact Fee Funds (DIF), by the
amount of \$477,000.

2. That the Chief Financial Officer, or designee, is further authorized to transfer
appropriations in the total amount of \$477,000 from Fund No. 400132, Serra Mesa Urban
Community Development Impact Fee Funds (DIF), to CIP S-00762, Angier Elementary School
Joint Use Park Improvements.

3. That the Chief Financial Officer, or designee, is authorized to appropriate, encumber, and expend an amount not to exceed \$477,000 from CIP S-00762, Angier Elementary School Joint Use Park Improvements, Fund No. 400132, Serra Mesa Urban Community Development Impact Fee Funds (DIF), for the sole and exclusive purpose of providing funds for construction of the park improvements.

4. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.


