A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A FIRST AMENDMENT TO THE CONSULTANT AGREEMENT WITH SIMON WONG ENGINEERING FOR THE GEORGIA STREET BRIDGE IMPROVEMENTS PROJECT.

WHEREAS, the Georgia Street Bridge is on the National Register of Historic Places; and

WHEREAS, Caltrans has determined the bridge to be functionally obsolete and seismically inadequate; and

WHEREAS, on December 16, 2008 the City entered into a consultant agreement with Simon Wong Engineering to provide preliminary engineering services related to the Georgia Street Bridge; and

WHEREAS, this amendment would provide additional scope to the consultant agreement with Simon Wong Engineering to provide an additional rehabilitation study to complete the Seismic Strategy Report as requested by Caltrans; and

WHEREAS, this first amendment will increase the consultant agreement with Simon Wong Engineering by \$493,000.00 for a total contract of \$735,968.00, and NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of said City, a First Amendment to the Agreement with Simon Wong Engineering, for engineering services under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR **307084**.

2. That the Chief Financial Officer is hereby authorized to expend an amount not to exceed \$493,000 from CIP S-00863, Georgia Street Bridge Improvements, Fund No. 600000, Federal Grant No. 1000128-2003, for the purpose of providing funds for the above referenced Project.

3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.


