A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER OF FUNDS FOR VARIOUS STORM WATER PROJECTS.

WHEREAS, the purpose of this action is to consolidate funds from several storm drain project accounts into projects currently in design and in need of funds; and

WHEREAS, the Hayes Avenue Storm Drain project will provide for improved flood control by upgrading the existing storm drain facility; and

WHEREAS, the Uptown Community Storm Drainage project is being cancelled and the upgrades proposed in the project will be completed in the Hayes Avenue Storm Drain project; and

WHEREAS, funding which was allocated to the Rose/Tecolote Creeks Water Quality Improvements (S-10002) is being moved to the annual allocation, Rose and Tecolote Creeks Water Quality Improvements; and

WHEREAS, this action will consolidate funding and allow for full funding of Mt. Abernathy Drive – Green Street project, a sublet of Rose and Tecolote Creeks Water Quality Improvements; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Chief Financial Officer is authorized to transfer appropriations in an amount not to exceed \$130,000 from CIP ACA-00001, Drainage Projects, to CIP S-11002, Hayes Avenue Storm Drain, within Fund 400121, Uptown Urban Community Fund; and

2. That the Chief Financial Officer is authorized to transfer appropriations in an amount not to exceed \$150,000 from CIP S-10060, Uptown Community Storm Drainage, to CIP S-11002, Hayes Avenue Storm Drain, within Fund 400121, Uptown Urban Community Fund; and

3. That the Chief Financial Officer is authorized to close CIP S-10060, Uptown Community Storm Drainage; and

4. That the Chief Financial Officer is authorized to expend \$280,000 from CIP S-11002, Hayes Avenue Storm Drain, within Fund 400121, Uptown Urban Community Fund, for the purpose of upgrading the storm drain facility; and

5. That the Chief Financial Officer is authorized to transfer remaining appropriations at project close-out from CIP S-10002, Rose and Tecolote Creeks Water Quality Improvements, to CIP ACC-00002, Rose and Tecolote Creeks Water Quality Improvements, within Fund 400631, Rose and Tecolote Creeks Water Quality; and

6. That the Chief Financial Officer is authorized to close CIP S-10002, Rose and Tecolote Creeks Water Quality Improvements; and

7. That the Chief Financial Officer is authorized to expend an amount not to exceed \$173,000 from CIP ACC-00002, Rose and Tecolote Creeks Water Quality Improvements (Job Order B-00663, Mt. Abernathy Drive-Green Street), within fund 400631, Rose and Tecolote

Creeks Water Quality, for the purpose of constructing green street improvements to improve the quality of storm runoff.
