A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING FUNDING AND TAKING
RELATED ACTION IN CONNECTION WITH EUCLID
AVENUE MISSING SIDEWALK – DWIGHT STREET
AND ISLA VISTA AVENUE.

WHEREAS, the east side of the sidewalk on Euclid Avenue between Dwight Street and Isla Vista Avenue is missing and funds are available from the City Heights Series 2010A Tax-Exempt Bonds for repair; and

WHEREAS, the City Heights Project Area Committee recommended funding for the repair; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That in accordance with the annual appropriation ordinance, the Chief Financial Officer is authorized to amend the Fiscal Year 2012 Capital Improvements Program to add CIP S-12027, Euclid – Dwight to Isla Vista Sidewalk, in the amount of \$206,000.
2. That the Chief Financial Officer, or designee, is authorized to accept up to \$206,000 from Fund No. 400815, City-City Heights Redevelopment Project Area 2010A Tax Allocation Bonds TE, and to deposit same into Fund No. 200641, CH-RDA Contribution to City CH-2010TE Bonds, for CIP S-12027, Euclid – Dwight to Isla Vista Sidewalk, contingent upon the Chief Financial Officer certifying that the funds necessary for expenditure are available for the sidewalk improvements.
3. That the Chief Financial Officer, or designee, is authorized to increase the Fiscal Year 2012 Capital Improvement Program Budget by an amount not to exceed \$206,000 in CIP S-12027,

Euclid – Dwight to Isla Vista Sidewalk, Fund No. 2000641, CH-RDA Contribution to City CH-2010TE Bonds.

4. That the Chief Financial Officer, or designee, is authorized to appropriate, encumber, and expend an amount not to exceed \$206,000 in CIP S-12027, Euclid – Dwight to Isla Vista Sidewalk, Fund No. 200641, CH-RDA Contribution to City CH-2010TE Bonds, solely and exclusively to provide funds for the sidewalk improvements.
