

RESOLUTION NUMBER R- 307102

DATE OF FINAL PASSAGE NOV 17 2011

WHEREAS, the Human Relations Commission (Commission) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 9 to advise the Mayor and City Council on the rights of every inhabitant of the City of San Diego to equal economic, political and educational opportunity; to equal accommodations in all business establishments in the City; and to equal service and protection by public agencies; and

WHEREAS, the Municipal Code provides that the Commission shall consists of fifteen members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Municipal Code provides that the members shall serve staggered four-year terms, except that all vacancies occurring during a term shall be filled for the remainder of the unexpired term;

WHEREAS, the Municipal Code provides that of the fifteen members: (1) the Mayor shall appoint seven members directly; and (2) the Mayor shall appoint eight additional members, one each from a list of up to three nominations submitted by each Councilmember; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the following reappointment and appointments by the Mayor of the City of San Diego, to serve as members of the Human Relations Commission, for the terms ending as indicated, are made and hereby confirmed:
