BE IT FURTHER RESOLVED, that pursuant to California Public Resources Code section 21081.6, the Council adopts the Mitigation Monitoring and Reporting Program, or alterations to implement the changes to the Projects as required by this body in order to mitigate or avoid significant effects on the environment, a copy of which is attached hereto and incorporated herein by this reference.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file two Notice of Determinations (NOD) with the Clerk of the Board of Supervisors for the County of San Diego regarding the above projects.
