A RESOLUTION AUTHORIZING THE MAYOR TO RENEW
THE CITY'S CONTRACTS FOR PERIODICAL
SUBSCRIPTION SERVICES FOR PERIODICALS FOR THE
SAN DIEGO PUBLIC LIBRARY.

WHEREAS, after a competitive bid process, the City of San Diego entered into two contracts for periodicals subscription services for the San Diego Public Library: one with EBSCO Subscription Service to provide subscriptions to periodicals listed on the City's Main Title List; and one with WT Cox Subscriptions to provide subscriptions to periodicals listed on the City's Spanish Title List (collectively, the "Subscription Contracts"); and

WHEREAS, the Subscription Contracts are for a period of two years beginning September 1, 2009, with three one-year options to renew; and

WHEREAS, both EBSCO and WT Cox have indicated their willingness to renew their respective Subscription Contract on the same terms and conditions as are currently contained in the contracts; and

WHEREAS, under the terms of the Subscription Contracts, subscription services are provided to the San Diego Public Library as requested by the City; and

WHEREAS, the City expects to require subscription services during the new contract year running from September 1, 2011 through August 31, 2012 in an amount not to exceed \$353,000; and


WHEREAS, for the first two years of the Subscription Contracts the City spent \$708,202 (\$693,349 with EBSCO, \$14,853 with WT Cox) for subscription services and expects to spend

\$353,000 in the third year, thereby necessitating the approval of the City Council for the renewal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, be and is hereby authorized and empowered to execute, for and on behalf of City, a renewal of the City's contracts for periodicals subscription services for a period of one year beginning September 1, 2011, on the terms and conditions set forth in the respective contracts dated August 26, 2009 (Bid No. 9500-09-L), on file in the office of the City Clerk as Document No. RR- 307123, as follows: Contract No. 4600000023 with EBSCO Subscription Service to provide subscriptions to periodicals listed on the City's Main Title List as requested by City up to an amount not to exceed \$346,000, for a total contract amount for services through August 31, 2012 not to exceed \$1,039,349; and Contract No. 4600000024 with WT Cox Subscriptions to provide subscriptions to periodicals listed on the City's Spanish Title List as requested by City up to an amount not to exceed \$7,000, for a total contract amount for services through August 31, 2012 not to exceed \$21,853; for a combined anticipated annual total not to exceed \$353,000 for the new contract year; and

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$353,000 from the General Fund—Library Department (Fund No. 100000) is authorized for payment to EBSCO Subscription Service and WT Cox Subscriptions for periodical subscription services for the contract year beginning September 1, 2011, pursuant to the terms and conditions of Contract No. 4600000023 and Contract No. 4600000024 (Bid No. 9500-09-L), on file in the office of the City Clerk as Document No. RR- 307123.
