WHEREAS, Claimants and the City propose to enter into a Settlement Agreement in order to settle all claims between them and release each other from any and all actions related to the Incident; NOW THEREFORE,

BE IT RESOLVED, that the Council for the City of San Diego authorizes the Mayor or a designee to execute a settlement and release of claims between the City of San Diego and Martin and Susie Ammerman; and

BE IT FURTHER RESOLVED, that the sum of \$97,490.52 is authorized to be paid in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the claims of Martin and Susie Ammerman; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend the amount of \$97,490.52 from the Public Liability Fund 720045 contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the Comptroller is authorized to issue a check in the amount of \$97,490.52 made payable to Martin and Susie Ammerman.
