A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE CONSULTANT AGREEMENT WITH HELIX ENVIRONMENTAL PLANNING, INC. TO PROVIDE ENVIRONMENTAL SERVICES RELATED TO THE UNIVERSITY AVENUE MOBILITY PLAN.

WHEREAS, in March of 2009 the City and Helix Environmental Planning, Inc. (Helix) entered into an agreement (City Clerk Document No. RR-304738) to develop a University Avenue Mobility Plan (UAMP); and

WHEREAS, the UAMP was to study transportation improvements to enhance safety and mobility along the University Avenue corridor for pedestrians, transit, and automobile traffic in the North Park community; and

WHEREAS, Caltrans has determined that the potential improvements identified by the UAMP require further environmental analysis to support a future improvement project; and

WHEREAS, the City and Helix now desire to amend their consultant agreement to include the environmental analysis requested by Caltrans for an additional amount not to exceed \$81,100.00; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of said City, a First Amendment to the Consultant Agreement with Helix Environmental Planning, Inc., for environmental consulting services under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 307161.

- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$81,100 from CIP S-00915, University Avenue Mobility Plan from Fund 400169, Transnet, for the purpose of funding the First Amendment to the Consultant Agreement with Helix Environmental Planning, Inc.
- 3. That the Chief Financial Officer is authorized to transfer excess budgeted funds, if any, to the appropriate reserve on advice of the administering department.
