A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH KLR PLANNING TO PROVIDE ENVIRONMENTAL CONSULTING SERVICES TO THE CITY FOR THE UPTOWN, NORTH PARK, AND GREATER GOLDEN HILL COMMUNITY PLAN UPDATES.

WHEREAS, in November 2009, the Planning Division of the Development Services Department commenced the updates to the Uptown, North Park, and Greater Golden Hill Community Plans; and

WHEREAS, as part of the work program for these plan updates, consultant disciplines representing the fields of public outreach, historic resource preservation, urban design, transportation planning, and Environmental Impact Report (EIR) preparation have been identified in the Planning Division budget to work as extensions of department staff for these plan updates; and

WHEREAS, the City conducted a competitive bidding process and selected KLR Planning to provide professional environmental consulting services for all three community plan updates;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with KLR Planning to provide environmental consulting services for the Uptown, North Park, and Greater Golden Hill Community Plan Updates in the amount of \$314,268

(Agreement).


2. That the City's Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$239,268 from Fund 100000 for the purpose of providing funds for the Agreement, its amendments and related costs.

3. That the City's Chief Financial Officer is authorized to accept an amount not to exceed \$75,000 from Fund 200359 – City North Bay Redevelopment Program Planning Studies Contributions for the purpose of providing funds for the Agreement, its amendments and related costs.

4. That the City Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
