A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE IN THE FY 2012 CAPITAL IMPROVEMENTS PROGRAM BUDGET FOR BUS STOP IMPROVEMENT PROJECTS.

WHEREAS, in July of 2008, the City and the San Diego Metropolitan Transit System (MTS) entered into an agreement whereby the City would receive a portion of revenues derived from the sale of advertising on MTS bus shelters placed within the City's public rights-of-way; and

WHEREAS, the agreement between the City and MTS requires that the revenues received by the City be used for bus stop improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Chief Financial Officer is authorized to amend the Fiscal Year 2012 Capital Improvements Program budget to increase CIP A-ID.00007, Annual Allocation Bus Stop Improvements, Fund 400691, Bus Stop Capital Improvements by the amount of \$108,947.35.
- 2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$108,947.35 from CIP A-ID.00007, Annual Allocation Bus Stop Improvements, Fund 400691 Bus Stop Capital Improvements, solely and exclusively for the purpose of providing funds for the Project, provided that the Chief Financial officer first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
