A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FISCAL YEAR 2012 BUDGET TO INCREASE THE AUTHORIZED POSITIONS OF THE SAN DIEGO POLICE DEPARTMENT BUDGET FOR ONE ADDITIONAL LIMITED LATENT PRINT EXAMINER AIDE POSITION.

WHEREAS, on April 22, 2011, the San Diego County Cal-ID/Remote Access Network (RAN) Board, a county-wide advisory board that makes recommendations on the distribution of Cal-ID funds, authorized the use of Cal-ID revenue to fund one full-time AFIS Entry Technician position from July 1, 2011, through June 30, 2012, in the City of San Diego; and

WHEREAS, the addition of the AFIS Entry Technician position is part of a strategy approved by the RAN Board to enter cases involving fingerprint or latent print analysis into the region's AFIS database in a timely manner; and

WHEREAS, on August 2, 2011, the San Diego County Board of Supervisors approved the recommendation of the RAN Board to fund one full-time AFIS Entry Technician position from July 1, 2011, through June 30, 2012, for the San Diego Police Department Crime Laboratory and for the San Diego County Sheriff's Department (Sheriff) to enter into a Memorandum of Agreement setting forth the terms and conditions of the funding; and

WHEREAS, this agreement will authorize the City of San Diego to accept reimbursement of up to\$73,333 from the Sheriff for the employment of one full-time AFIS Entry Technician position entitled Latent Print Examiner Aide for the San Diego Police Department Crime Laboratory from July 1, 2011, through June 30, 2012; and

WHEREAS, the San Diego City Council authorizes the San Diego Police Department to enter into a Memorandum of Agreement with the Sheriff setting forth the terms and conditions of the funding from the RAN Board for a term from July 1, 2011, through June 30, 2012, and will automatically renew each fiscal year for four years until June 30, 2016, unless terminated by either party; and

WHEREAS, the City of San Diego will submit a reimbursement request to the Sheriff on a quarterly basis for the actual cost of salaries and benefits of the personnel under this agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. The Chief Financial Officer to increase appropriations to the revenue by \$73,333 in the General Fund (100000), Police Department (1914) for one full-time AFIS Entry

 Technician position entitled Latent Print Examiner Aide from reimbursable revenue from the San Diego County Cal-ID/Remote Access Network (RAN) Board.
- 2. The Chief Financial Officer to increase appropriations to expend \$73,333 in the General Fund (100000), Police Department (1914) for one full-time AFIS Entry Technician position entitled Latent Print Examiner Aide.
- 3. The Mayor or his representative is authorized, for and on behalf of the City, to enter into an agreement with the County for the purpose of funding one full-time AFIS Entry
