A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO THE JACOBS CENTER FOR NEIGHBORHOOD INNOVATION FOR THE FIFTH ANNUAL HOLIDAY ENTERTAINMENT FOR TROLLEY RIDERS PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, the Jacobs Center for Neighborhood Innovation (JCNI) is a non-profit organization which partners with resident teams in underinvested neighborhoods in East San Diego; and

WHEREAS, the JCNI has requested funding for the Fifth Annual Holiday Entertainment Series for trolley riders, which provides entertainment for trolley riders at the Orange Line's 62nd Street and Encanto trolley stations; and

WHEREAS, JCNI will be working in collaboration with the Metropolitan Transit System (MTS), and the Coca-Cola company to produce the above-described entertainment; and

WHEREAS, it is the determination of the Council that the above-described program fits

within the parameters of Council Policy 100-06, Community Projects, Programs and Services;

WHEREAS, Council District Four recommends an allocation of \$5,000 to JCNI, for the

purpose of the Fifth Annual Holiday Entertainment Series for trolley riders; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the allocation described

herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to

negotiate and execute for and on behalf of the City, an Agreement with the Jacobs Center for

Neighborhood Innovation in an amount not to exceed \$5,000 for the Fifth Annual Holiday

Entertainment Series for trolley riders program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to

appropriate and expend up to \$5,000 from Council District Four Community Projects, Programs

and Services budget, Fund No. 100000, to provide funds for the above referenced agreement,

contingent upon the City Comptroller first furnishing one or more certificates certifying that the

funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
