A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING APPOINTMENTS TO THE  
STANDING COMMITTEES FOR CALENDAR YEAR 2012.

WHEREAS, Rule 6.1 of the Permanent Rules of the City Council, San Diego Municipal Code section 22.0101, provides that there shall be five standing committees of the City Council; and

WHEREAS, Rule 6.2.1 provides that, for each committee, except for the Committee on Rules, Open Government, and Intergovernmental Relations (Rules Committee), the Council President shall, no later than the second meeting of the Council in January of each year, nominate the committee Chair, vice-chair, and committee members, subject to confirmation by a majority vote of the City Council; and

WHEREAS, Rule 6.10.1 states that the Council President shall serve as the Chair of the Rules Committee and that the Council President Pro Tem shall serve as the Vice-Chair; and

WHEREAS, the City Council has selected Councilmember Anthony Young to serve as Council President for a second term, which commenced on December 5, 2011; and

WHEREAS, the Council President has submitted nominations for each committee Chair, vice-chair, and committee members for calendar year 2012; and


WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to section 22.0101 of the San Diego Municipal Code, the following appointments by the Council President to serve as Chairs, vice-chairs, and committee members of the following standing Council committees, to serve for a term of one year and until a successor is duly appointed and confirmed, are hereby confirmed:
