AN ORDINANCE OF THE CITY OF SAN DIEGO APPROVING AN AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO MUNICIPAL EMPLOYEES' ASSOCIATION REGARDING POST-EMPLOYMENT HEALTH BENEFITS FOR ELIGIBLE EMPLOYEES WHO RETIRE AFTER MARCH 31, 2012

WHEREAS, on February 7, 2012, the San Diego City Council (Council) adopted Ordinance O-20134, which approved and ratified the Memorandum of Understanding between the City of San Diego (City) and the San Diego Municipal Employees Association (MEA) for the term of April 1, 2012, through March 31, 2027, regarding the Post-Employment Health Benefits for eligible employees who retire after March 31, 2012 (MOU); and

WHEREAS, under the terms of the MOU, employees who elect Option A or B under the Post-Employment Health Benefits Plan are required to make mandatory employee contributions; and

WHEREAS, the MOU provided that the employee contributions would be pre-tax, subject to applicable federal tax laws; and

WHEREAS, after the MOU was approved by Council, the City was advised by its outside tax counsel that employee contributions would have to be made post-tax to comply with applicable federal tax laws; and

WHEREAS, this advice required further negotiations between the City and MEA under the Meyers-Milias-Brown Act (MMBA); and

WHEREAS, on May 1, 2012, the City's labor negotiators met and conferred with MEA and reached agreement with MEA to amend the 15-year MOU and modify the employee contributions to comply with federal tax laws; and

WHEREAS, the Council desires to approve the agreed upon modifications to the

Option A and B mandatory employee contributions, as reflected in the Amendment to

Memorandum of Understanding Regarding Post-Employment Health Benefits between the City

and MEA; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to the Meyers-Milias-Brown Act and City Council

Policy 300-06, the City Council approves the Amendment to Memorandum of Understanding

Regarding Post-Employment Health Benefits between the City and MEA for the term of

April 1, 2012, through March 31, 2027, on file in the Office of the City Clerk as Document
