DATE OF FINAL PASSAGE NOV 27 2012

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 18, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.1801 RELATING TO COUNCIL DISTRICT NINE.

WHEREAS, on June 8, 2010, voters approved an amendment to the San Diego Charter to create a ninth Council district; and

WHEREAS, on August 25, 2011, the Redistricting Commission adopted a plan that adjusted the boundaries of all the Council districts to reflect population changes and add the ninth Council district; and

WHEREAS, at the June 5, 2012 municipal primary election, voters elected a Councilmember for the ninth Council district; and

WHEREAS, the Councilmember elected to represent the ninth Council district will be sworn into office on December 3, 2012; and

WHEREAS, it is now appropriate to amend the San Diego Municipal Code to reflect the new Council District 9 as a City department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 18 of the San Diego Municipal Code is amended by amending section 22.1801 to read as follows:

§22.1801 City Departments

- (a) Purpose and Intent.

It is the purpose and intent of the City Council to enumerate the existing departments of the City because of repeated reference in City legislation and operation to such departments.

- (b) The following are the departments of the City of San Diego within the meaning of the Charter and ordinances of said City:


- (c) The department head for each department of City Council - Districts 1 through 9 shall be the duly elected or appointed Councilmember from the district.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


