AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A FOURTH AMENDMENT TO THE CONSULTANT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND KIMLEY-HORN, INC. FOR THE INTERSTATE 5 AND GENESEE AVENUE OVERCROSSING PROJECT.

WHEREAS, the City in cooperation with Caltrans is expanding the Genesee Avenue and Interstate 5 overcrossing; and

WHEREAS, on February 9, 2004 the Council authorized (R-298854) an agreement with of Kimley-Horn, Inc. for preliminary engineering services related to the Interstate 5 and Genesee Avenue Interchange; and

WHEREAS, on February 14, 2007 the Council authorized (R-302321) a 1st amendment to the agreement with Kimley-Horn, Inc to incorporate various proposed improvements related to the Caltrans Interstate 5 Corridor Project; and

WHEREAS, on December 15, 2008, the Council (O-19817) authorized a 2nd amendment to the agreement with Kimley-Horn, Inc. include additional geotechnical investigations and environmental studies; and

WHEREAS, on December 15, 2011 the Council (O-20118) authorized a 3rd amendment to the agreement with Kimley-Horn, Inc. to prepare the final project design; and

WHEREAS, the City and Kimley-Horn, Inc. now desire to enter a 4th amendment to address updated project design requirements including water quality, the design of utilities within a bridge, and project staging for the Genesee Avenue and Interstate 5 Overcrossing Project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of

the City, a Fourth Amendment to the consultant agreement with Kimley-Horn, Inc. for

engineering services in connection with the Genesee Avenue / Interstate-5 Overcrossing Project

in an amount not to exceed \$1,103,708 and under the terms and conditions set forth in the Fourth

Amendment, on file with the City Clerk as Document No. OO- 20225.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to

exceed \$1,103,708 from CIP S-00839, Genesee Avenue / Interstate-5 Overcrossing, from the

North University City FBA, Fund No. 400080, solely and exclusively to provide funds for the

above Fourth Amendment to the Consultant Agreement with Kimley-Horn, Inc.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage,

a written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
