DATE OF FINAL PASSAGE JAN 23 2012

A RESOLUTION APPROVING PLANS AND SPECIFICATIONS, AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT, AND RELATED ACTIONS FOR WATER GROUP JOB 928.

WHEREAS, Water Group Job 928 (Project) is part of the City of San Diego's Program mandating the replacement of all cast iron water mains as mandated by the California Department of Public Health; and

WHEREAS, this Project is located in the Greater North Park community and consists of the replacement of approximately 5,265 linear feet of water mains and all other work and appurtenances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego (Council) that the plans and specifications for the construction of the Project, as advertised by the Purchasing and Contracting Department, filed in the office of the City Clerk as Document No. 307216, are approved.


BE IT FURTHER RESOLVED, that after advertising for bids in accordance with law, the Mayor or his designee is authorized to execute a construction contract with the lowest responsible and reliable bidder, provided that the Chief Financial Officer (CFO) first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the CFO, as delegated to Financial Management is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$2,379,982.00 from Water Fund 700010, CIP A-KB.00003, Main Replacements

contract, provided that the Chief Financial Officer first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the use of City Forces Work in Fund 700010, CIP A-KB.00003, Main Replacements (B-10188) in an amount not to exceed \$233,320 is authorized for the construction of the Project.
