A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO ADOPTING NEGATIVE DECLARATION  
NO. 215049 FOR THE PASATIEMPO REZONE AND  
TECHNICAL COMMUNITY PLAN AMENDMENT PROJECT.

WHEREAS, on July 6, 2010, Steve McKinley submitted an application to the Development Services Department for the purpose of changing 0.62 acres, located at 6250 Pasatiempo Avenue (Project Site), as shown on Zone Map Drawing No. B-4290, on file in the Office of the City Clerk as Document No. OO - 20136, from the OP-2-1 zone to the RS-1-7 zone and amending the Navajo Community Plan to correct a mapping error by changing the land use designation for the Project Site from Park to Single Family Residential; and

WHEREAS, the matter was set for a public hearing to be conducted by the City Council of the City of San Diego; and

WHEREAS, the issue was heard by the City Council on JAN 31 2012; and


WHEREAS, the City Council of the City of San Diego considered the issues discussed in Negative Declaration No. 215049, NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that it is hereby certified that Negative Declaration No. 215049 has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code Sections 21000 *et seq.*) as amended, and the State guidelines thereto (California Administrative Code Sections 15000 *et seq.*), that the document reflects the independent judgment of the City of

San Diego as Lead Agency, and that the information contained in said document, together with any comments received during the public review process, has been reviewed and considered by the City Council and therefore, the City Council hereby adopts the Negative Declaration, a copy of which is attached hereto and incorporated by reference.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Determination (NOD) with the Clerk of the Board of Supervisors for the County of San Diego regarding the Project after final passage of O-20136 rezoning the site from the existing OP-2-1 Zone into the RS-1-7 Zone.
