A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A THIRD AMENDMENT TO THE LEASE AGREEMENT WITH HAWTHORNE MACHINERY FOR HEAVY DUTY TRACTOR BULLDOZERS, WITH ONE ONE-YEAR OPTION TO RENEW THE AGREEMENT, AND AUTHORIZING EXPENDITURES OF FUNDS THEREFOR.

WHEREAS, the Council in May 2010 by Resolution No. R-305868 authorized an agreement with Hawthorne Machinery Company [Hawthorne] for the lease of heavy duty tractor bulldozers for daily operations at the Miramar Landfill in accordance with Request for Bid No. 9469-09-Y and Hawthorne's response thereto [Agreement]; and

WHEREAS, the Council in July 2010 by Resolution No. R-305979 authorized an amendment to the Agreement to extend its term, and in March 2011 by Resolution No. R-306659 authorized a further amendment to extend the Agreement through March 14, 2012, with two additional one-year options to renew the Agreement remaining; and

WHEREAS, the Environmental Services Department wishes to exercise the option for an additional one-year period to extend the Agreement to March 14, 2013; and

WHEREAS, the Natural Resources & Culture Committee heard this item on February 1, .
2012, and recommended approval to the full City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a third amendment to the Agreement with Hawthorne Machinery Company for the lease of heavy duty tractor bulldozers with full maintenance, extending the term of the Agreement from March 15, 2012 through March 14, 2013, with an option to renew for one additional one-year period, all

in accordance with Request for Bid No. 9469-09-Y and under the terms and conditions set forth in the Third Amendment to the Agreement, on file with the City Clerk as Document No. RR-307284

- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,625,000 from Refuse Disposal Fund No. 700039, solely and exclusively to provide funds for the Third Amendment, contingent on passage of the Annual Appropriations Ordinance for the applicable fiscal year and provided that the City Comptroller first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury for the Third Amendment.
- 3. That the Mayor or his designee is authorized to exercise the last option to extend the above Agreement for up to one additional one-year period, under the terms and conditions set forth in the Agreement.
- 4. That if the Mayor determines to exercise the last one-year option to extend the Agreement, the Chief Financial Officer is authorized to expend an amount not to exceed \$1,625,000 plus a potential price escalation not to exceed 5% of the price in effect at the end of the prior Agreement year, as set forth in the Agreement, to be expended from Refuse Disposal Fund No. 700039 and contingent on: (i) execution of an appropriate amendment to the Agreement; (ii) passage of the Annual Appropriations Ordinance for the applicable fiscal year; and (iii) the City Comptroller first furnishing one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.
