A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO DE-APPROPRIATE FUNDS FROM THE NORTH PACIFIC BEACH LIFEGUARD STATION.

WHEREAS, on March 18, 2011, by Resolution No. R-306656, the Council of the City of San Diego approved a revision to the allocation of Deferred Maintenance Funds; and

WHEREAS, as part of the revised allocation, \$740,000 was transferred from the Ocean Beach Lifeguard Station project to the North Pacific Beach Lifeguard Station project (Project) to complete the design portion of the Project; and

WHEREAS, in addition, \$550,000 of the Pacific Beach Urban Development Impact Fees (DIF) had been allocated to the Project; and

WHEREAS, since all of the funding for the future construction of the Project have not been fully identified, \$400,000 from the Pacific Beach Urban DIF funding will be returned to the Pacific Beach Urban DIF fund balance; and

WHEREAS, the design of this Project will proceed and be completed with the available fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to de-appropriate \$400,000 from WBS No. S-10119, North Pacific Beach Lifeguard Station, Fund No. 400117, Pacific Beach Urban DIF Fund.
