A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE LIBRARY'S APPLICATION FOR, RECEIPT, AND EXPENDITURE OF \$15,000 OF GRANT FUNDING FROM THE CALIFORNIA COUNCIL FOR THE HUMANITIES FOR THE FY 2012 CALIFORNIA READS PUBLIC LIBRARY GRANT PROGRAM.

WHEREAS, the San Diego Public Library is requesting authorization to accept and expend \$15,000 in funding from the California Council for the Humanities (CCH) California Reads Public Library Grant program; and

WHEREAS, the Library will use the funds to implement a public dialog program based on a selected book about the United States Constitution and called, "Search for Democracy: A Public Conversation About the Constitution;" and

WHEREAS, in implementing the program, the Library will partner with other San Diego organizations, including the Thomas Jefferson Law School and KPBS, to provide speakers and media coverage for the program; and

WHEREAS, the Library's proposed program has been approved for funding by CCH for the maximum amount available of \$15,000, and requires that the City match that amount using non-federal funds and/or in-kind services and materials; and

WHEREAS, the City's one-hundred percent match will be made using previously authorized and budgeted personnel and non-personnel expense, and previously authorized and budgeted Library Matching Program Fund NPE; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor or his designee is hereby authorized to apply, accept, appropriate

and expend \$15,000 in FY 2012 grant funds from the California Council for the Humanities'

California Reads Public Library Grant program in Fiscal Year 2012 for the purpose of

implementing the Library's program, "Search for Democracy: A Public Conversation About the

Constitution," and to execute all grant agreements necessary to comply with the grant

requirements and take all actions necessary to secure the grant funding.

2. That the Chief Financial Officer is authorized to accept, appropriate and expend

up to \$15,000 of the Fiscal Year 2012 grant funding.

3. That the Chief Financial Officer is authorized to establish a special interest-

bearing account for the California Council for the Humanities California Reads Public Library

Grant for Fiscal Year 2012.
