

RESOLUTION NUMBER R- 307298

DATE OF FINAL PASSAGE MAR 15 2012

WHEREAS, section 41.1 of the Charter of the City of San Diego established the Salary Setting Commission to recommend to the Council the enactment of an ordinance establishing salaries for the Mayor and Council as provided by the Charter; and

WHEREAS, section 12.1 pertaining to Councilmember salaries and section 24.1 pertaining to the Mayor's salary require that the Commission's recommendation be presented on or before February 15 of every even year, said salaries to be effective the following July 1 for a two-year period; and

WHEREAS, during the Fiscal Year 2012, the Commission conducted extensive research and held a series of public hearings to determine and ascertain facts sufficient to establish salary levels for recommendation to the Mayor and Council for adoption by ordinance as required by the Charter; and

WHEREAS, the Commission pursuant to the mandate of the Charter, presented its recommendations in a letter dated February 7, 2012 to the Mayor and Council; and

WHEREAS, the Commission recommended increases in annual compensation for the Mayor and City Council as follows:

WHEREAS, pursuant to sections 12.1 and 24.1 of the Charter, the Council may adopt the salaries as recommended by the Commission, or in some lesser amount; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the salaries for the Mayor and Council remain unchanged from the FY 2012 salaries; and that the City Attorney is directed, pursuant to section 41.1 of the Charter, to incorporate the following amounts in the annual salary ordinance for Fiscal Year 2013 to be effective July 1, 2012, and the annual salary ordinance for Fiscal Year 2014 to be effective July 1, 2013:
