A RESOLUTION AUTHORIZING RE-ADVERTISING,
ADDITIONAL EXPENDITURE OF FUNDS AND APPROVING
PLANS AND SPECIFICATIONS FOR CONSTRUCTION OF
ALVARADO TRUNK SEWER PHASE III.

WHEREAS, on October 5, 2011, by Resolution Number R-307021, the Council of the City of San Diego [Council] authorized the award and expenditure of funds for the construction of Alvarado Trunk Sewer Phase III [Project]; and

WHEREAS, the Project was advertised and the apparent lowest responsible and reliable bid for the Project was higher than the Engineer's estimate and all bids failed to comply with the City's contracting requirements; and

WHEREAS, additional funds are needed to re-advertise, and for construction of the Project; and


WHEREAS, the Council, stating for the record, that the information contained in the Mitigated Negative Declaration, Project No. 209815, including any comments received during the public review process, has been previously reviewed and considered by Planning Commission of the City of San Diego and it is determined that no substantial changes or new information of substantial importance within the meaning of CEQA Guidelines section 15162 would warrant any additional environmental review in connection with approval of the Project;
NOW, THEREFORE,

BE IT RESOLVED, by the Council that the plans and specifications for the construction of the Project, as re-advertised by the Purchasing and Contracting Department, filed in the office of the City Clerk as Document No. 307302, are approved.

BE IT FURTHER RESOLVED, that after re-advertising for bids in accordance with law, the Mayor, or his designee is authorized to execute a construction contract with the lowest responsible and reliable bidder, provided that the City Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer [CFO], as delegated to Financial Management is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$3,762,000, of which \$2,043,300 was previously authorized by R-307021 from Sewer Fund 700008, CIP A-JB.00001, Annual Allocation – MWWD Trunk Sewers (B-00481) for the Project's construction contract, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
