BE IT FURTHER RESOLVED, that the use of City Force work in Water Fund 700010,

CIP A-KB.00003, Annual Allocation - Water Main Replacements (B-00125) in the amount not

to exceed \$750,000 is authorized for the purpose of construction and related costs of the project.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of

Determination [NOD] with the Clerk of the Board of Supervisors for the County of San Diego

regarding the Project.
