A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE AGREEMENT WITH ALLIED WASTE SYSTEMS, INC. FOR REFUSE & RECYCLING COLLECTION SERVICES FOR CITY FACILITIES, WITH OPTIONS TO RENEW, AND AUTHORIZING EXPENDITURES OF FUNDS THEREFOR.

WHEREAS, in March 2010 by Resolution No. R-305700, the Council authorized an agreement with Allied Waste Systems, Inc., doing business as Allied Waste Services of San Diego ("Allied"), for City-wide refuse and recycling collection services at City facilities; and WHEREAS, the agreement was for a period of two years, from April 1, 2010 through March 31, 2012, with three one-year options to renew the agreement; and

WHEREAS, the City wishes to renew the agreement for an additional one year term through March 31, 2013; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a first amendment to the agreement with Allied, to provide City-wide refuse and recycling collection services at City facilities for the period April 1, 2012 through March 31, 2013, and under the terms and conditions set forth in the Amendment No. 1, on file with the City Clerk as Document No. RR 307316
- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$700,000 from General and Non-General Funds, as set forth in the attached Exhibit A and incorporated herein by reference, solely and exclusively to provide funds for Amendment No. 1,

contingent on Council approval of funding for these expenditures in the applicable fiscal years and provided that the City Comptroller first furnishes one or more certificates demonstrating that the funds for these expenditures are, or will be, on deposit in the City Treasury.

- 3. That the Mayor or his designee is authorized to exercise one or more options to extend the agreement for up to two additional one-year periods, under the terms and conditions set forth in the agreement.
- 4. That if the Mayor determines to exercise one or more options to renew the agreement, the Chief Financial Officer is authorized to expend an amount not to exceed \$800,000 per option year to be expended from General and Non-General Funds listed in the attached Exhibit "A," contingent on (i) execution of a written amendment to the agreement for each option year; (ii) passage of the Annual Appropriations Ordinance for the applicable fiscal year; and (iii) the City Comptroller first furnishing one or more certificates demonstrating that funds for the option year are, or will be, on deposit in the City Treasury.
