WHEREAS, the legal fees of Squires Sanders are not expected to exceed \$130,000, and the out-of-pocket expenses shall not exceed \$6,900 and the legal fees and costs will be paid from the bond proceeds only upon the successful closing of the 2012A Refunding Bonds; NOW THEREFORE,

an amount not to exceed \$130,000 plus out-of-pocket expenses not to exceed \$6,900 for such

issues a Comptroller's Certificate certifying that the funds necessary for such expenditure are, or

will be, on deposit with the City Treasurer.
