A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING NEW COUNCIL POLICY NO. 000-31 REGARDING CAPITAL IMPROVEMENT PROGRAM TRANSPARENCY AND AMENDING COUNCIL POLICY NOS. 000-29, 600-24, AND 600-33, REGARDING BID PROTESTS, COMMUNITY PLANNING GROUPS AND COMMUNITY INPUT ON PARK PROJECTS.

WHEREAS, the City has identified ways to streamline the Capital Improvement Program project delivery process through amendments to the Municipal Code as proposed in ordinances being introduced concurrently with this resolution; and

WHEREAS, the proposed ordinances, if approved, make it necessary to adopt a new Council Policy regarding transparency in the Capital Improvement Program process, and to amend the existing Council Policy regarding bid protests; and

WHEREAS, the City has also identified a conflict between Council Policies regarding community review of proposed park development projects that needs to be resolved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Council Policy No. 000-31 titled "Capital Improvement Program Transparency" is established as set forth in the Council Policy on file with the City Clerk as Document No.




BE IT FURTHER RESOLVED, that the City Clerk is instructed to add the aforesaid to the Council Policy Manual.
