WHEREAS, on August 16, 2005 current and former San Diego Police Department officers filed a lawsuit against the City in the case of *Marcus R. Abbe*, et al. v. City of San Diego, USDC Case No. 05cv1629 DMS ["SDPOA#2"]. The case was consolidated by the United States District Court with a related case, *Brett H. Burkett*, et al. v. City of San Diego, USDC Case No. 06cv538 DMS. There were approximately 1500 Plaintiffs; and

WHEREAS, the City engaged outside counsel, Latham & Watkins, LLP to defend it in the lawsuit; and

WHEREAS, the City prevailed in the lawsuit at a jury trial, and approximately 174 of the 1500 Plaintiffs unsuccessfully appealed the judgment against them to the United States Court of Appeals for the Ninth Circuit, Case Nos. 09-56437, 09-56444, 10-55087, and 10-55089 and the United States Supreme Court, Case No. 11-673; and

WHEREAS, Latham & Watkins, LLP incurred additional expenses of \$68,757.20 to defend the City in the appeal; NOW THEREFORE,

BE IT RESOLVED that the City's Chief Financial Officer is authorized to expend an amount not to exceed \$68,757.20 from the Public Liability Fund, solely, and exclusively for the purpose of final payment for the legal services and related legal services rendered in the

appeal arising out of Marcus Abbe, et al v. City of San	n Diego, USDC Case Nos. 05cv1629 and
