A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AMENDMENTS TO THE LAND DEVELOPMENT MANUAL BIOLOGY GUIDELINES.

WHEREAS, San Diego Municipal Code section 111.0106 provides that the City may establish and adopt submittal requirements, review procedures, and standards and guidelines for development to supplement the Land Development Code to be known as the Land Development Manual; and

WHEREAS, the City Council of the City of San Diego (Council) adopted the most recent Biology Guidelines as part of the Land Development Manual by Resolution No. R-293254 on June 6, 2000; and

WHEREAS, amendments to the Environmentally Sensitive Land Regulations are proposed, which include the establishment of the development scenarios under which a deviation from the sensitive biological resources regulations may be requested outside of the Coastal Zone; and

WHEREAS, amendments to the Land Development Manual Biology Guidelines, on file in the Office of the City Clerk as Document No. RR-307377, are proposed to establish criteria for each development scenario and to assist in making existing deviation findings, and to make other minor clarifications including updating references and adding language to be consistent with Appendix A of the Multiple Species Conservation Plan Subarea Plan with respect to the burrowing owl; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Amendments to the Land Development Manual Biology Guidelines, on file in the Office of the City Clerk as

Document No. RR-30737 (Biology Guidelines Amendments), are approved contingent upon final passage of O-20161 relating to deviations from the requirements of the Land Development Code regarding wetlands.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to insert the appropriate Resolution Number, once known, in the blank space provided in Section IV(B) of the Biology Guidelines Amendments.
