DATE OF FINAL PASSAGE MAY 29 2012

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE FISCAL YEAR 2013 BUDGET REPORTS FOR SPECIFIED BUSINESS IMPROVEMENT DISTRICTS AND LEVYING ANNUAL ASSESSMENTS.

WHEREAS, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) the Business Improvement Districts below were formed to levy assessments annually to pay for certain improvements and activities within the Business Improvement Districts; and

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07 ("Business Improvement Districts"), wishes to continue the improvements and activities of specified Business Improvement Districts in the City of San Diego; and

WHEREAS, on MAY 15, 2012, the City Council adopted Resolution No. R- 307451, in which the City Council approved the Fiscal Year 2013 Budget Reports for specified Business Improvement Districts in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:




